- A. The Bridge Program will serve highly vulnerable individuals and families experiencing literal or chronic homelessness, primarily referred through Coordinated Entry and community partners providing outreach services.
- B. Bridge Program staff will work collaboratively with CCH service teams and outside partners to provide households with completion of applications for housing, outreach to landlords, searches for appropriate housing units and access to needed wraparound services such as medical, behavioral health, substance use, and other clinical treatment.
- C. Once Bridge Program participants transition into their permanent supportive housing, they will be provided with ongoing case management, clinical counseling, and other supports to help them maintain housing stability.
