Some services include trash and graffiti removal, maintenance of the trash receptacles, pedestrian light poles, banners and, installation of wayfinding kiosks, art murals and sculptures, and benches. Other initiatives and efforts include working with the police and providing small safety grants to the district ratepayers, and helping businesses navigate through city channels.

Nikki Hazamy, Denver to serve as a business owner in the District, for a term expiring December 31, 2022, appointed;
