This contract provides extended warranty, repair or replacement, preventive maintenance, on-call and on-site emergency 24/7 technical support for all Emergency Communications System (formerly known as Voice Paging System) equipment and software manufactured by IED. In addition, the contract includes updating computer and controllers' operating systems from Windows 7 to Windows 10 and installing vetted monthly cybersecurity updates to the operating system.
