Denver International Airport (DEN) requested proposals from qualified entities to develop and operate the offered C East Expansion Food and Beverage Marketplace opportunity. After submittal and evaluation of responsive proposals, the Independent Evaluation panel recommended that Tastes DEN JV, LLC (Aviano Coffee, Senor Bear and Bar Dough) be selected for direct negotiations. The location will be 8,572 sq. ft., for the concourse level space and 2,621 sq. ft., for the ramp level kitchen space, total 11,193 sq. ft.
