Executive Summary with Rationale and Impact:

The Budget and Management Office is requesting a \$4.0 million supplemental appropriation for the Office of Economic Development's Business Incentive Fund (BIF). OED applies these funds to support specific business attraction opportunities. By separate resolution request, OED is seeking to use these BIF funds to establish a general merchandise mass retail store on the 16th Street Mall at 1601 California St.

As of February 6th, 2017 General Fund contingency will stand at \$22.76 million (pending approval of supplemental request CB 17-0049). This transaction would reduce General Fund Contingency to \$18.76 million or 72.2% of the original balance.
