**A resolution approving a proposed Amendatory Agreement between the City and County of Denver and Interlock Construction Corp. to add compensation and add two years for a new end date for on-call construction services as needed citywide.**

Amends a contract with Interlock Construction Corp. by adding \$10 million for a new total of \$25 million and two years for a new end date of 6-26-24 for on-call construction services as needed, including deferred maintenance and renovation work, in municipal buildings, citywide (DOTI-202160293-01; 201947346-01). The last regularly scheduled Council meeting within the 30-day review period is on 11-8-21. The Committee approved filing this item at its meeting on 10-5-21.
