Established thru Senate Bill 91-94, the Colorado Youth Detention Continuum (CYDC) program provides funding to

jurisdictions to implement alternatives to incarceration for youth. CYDC program staff are responsible for screening youth who have been charged with a misdemeanor and/or felony offense to determine release disposition and providing pre-trial release services which allows the youth to be supervised in the community in lieu of remaining in detention while the case proceeds through the juvenile justice system.
