**Title:** A bill for an ordinance amending Ordinance No. 436, Series 2008 that revised Chapter 38, Article I, Section 38-8 of the Revised Municipal Code pertaining to Offenses, Miscellaneous Provisions by removing the repeal date of November 20, 2010.  
Removes the sunset provision in the ordinance prohibiting smoking on the public rights-of-way adjoining hospitals and hospital-owned properties in the City & County of Denver which is set to expire on November 20, 2010.
