Amends a contract with Ricondo & Associates, Inc. by adding \$750,000 for a new total of \$2,125,000 for on-call planning services related to airport and aviation planning, including airport master planning, terminal development related studies, airport landside planning, airfield and systems-related capacity studies at Denver International Airport.
