Approves a funding and assignment agreement with the Denver Health and Hospital Authority for the construction of improvements totaling an amount not to exceed \$75 million as approved by voters in the 2017 General Obligation Bond package. Executive Summary with Rationale and Impact:

In November 2017, voters approved a General Obligation Bond measure which included City authorization to issue a total of \$75 million for financing the cost of health and human services system facilities, including improvements and renovations to Denver Health and Hospital Authority buildings (Measure 2C). In support of the GO bond vote, this resolution request seeks approval for a Funding and Assignment Agreement between the City and County of Denver and the **Denver Health and Hospital Authority** for the construction of a new outpatient medical center totaling an amount not to exceed \$75 million in general obligation bond proceeds. The Funding and Assignment Agreement provides for bond proceeds (to the extent issued) to be transferred from the City to Denver Health.

- Final accounting for expenditures on project
- Records retention and audit provisions
