A resolution approving a proposed Agreement between the City and County of Denver and DIA Juice, LLC to design, build, and operate a Jamba Juice concession at Denver International Airport.

Approves a premium value concession contract with DIA Juice, LLC operating as Jamba Juice, for a minimum annual guarantee of \$272,213 for a term of 7 years to design, build, manage, and lease a Jamba Juice on C concourse in the airport, in Council District 11. 202369789. The last regularly scheduled Council meeting within the 30-day review period is on 11-27-2023. The Committee approved filing this item at its meeting on 10-25-2023. Councilmember Parady called out this item, en bloc, at the 11-06-2023 meeting for a one-week postponement to 11-13-2023.

DIA Juice, LLC, dba Jamba Juice

Type and Scope of services to be performed:

DIA Juice, LLC will design, build, manage, and lease a Jamba Juice on Concourse C, West Subcore 1. DIA Juice, LLC has committed to investing a minimum of \$351,505.00 to design and build this space. To amortize DIA Juice, LLC capital investment, they will receive a contract term of 7 years. Denver International Airport (DEN) will receive the greater of either a guaranteed rent/Minimum Annual guarantee (MAG) of \$272,213.00 or a

percentage rent of gross sales at 16%. MAG is the initial calculation based on the projected gross sales by the concessionaires for the space multiplied by the proposed percentage fee listed above. MAG is recalculated each contract year and will be equal to the greater of the initial MAG or eighty-five (85%) of the total Privilege fees payable in the prior Contract Year.
