Decatur St. and 2775 W. 13th Ave. from I-MX-5, UO-2, I-A, UO-2 (industrial and light industrial, mixed use, 5 stories, use overlay allowing billboards) and C-MU-30 with waivers and conditions, UO-1 (commercial mixed use, high intensity, use overlay allowing adult businesses) to C-MX-8 (urban center, mixed use, 8 stories), and C-MX-8 UO-1 (urban center, mixed use, 8 stories, use overlay allowing adult businesses) in Council District 3.
