The ordinance will approve the second amendment and restatement of the intergovernmental agreement between the City and DHHA that has been in effect since 1997, and the appendices to the agreement for fiscal year 2018. The contract will reflect new funding levels and other necessary adjustments for 2018. The proposed contract amount is for the City to expend funds of \$64,047,203 for DHHA services and the City to receive funds of \$2,526,371 for City services provided to DHHA.
