The Stapleton "Five Parties" (City and County of Denver, Denver Urban Renewal Authority, Denver Public Schools, Forest City and Park Creek Metropolitan District) have agreed on an arrangement to allow for additional funding and to complete construction of an additional school, a fire station and other infrastructure at Stapleton.

This arrangement includes an agreement between the City and Park Creek Metropolitan District where the City contracts with the District to design and construct the final span of Central Park Boulevard over Sand Creek for a maximum of \$8.4 million.

This ordinance will set up a capital grant fund and appropriate the budget for this grant as follows:
