The Stapleton "Five Parties" (City and County of Denver, Denver Urban Renewal Authority, Denver Public Schools, Forest City and Park Creek Metropolitan District) have agreed on an arrangement to allow for additional funding and to complete construction of an additional school, a fire station and other infrastructure at Stapleton.

This arrangement includes an agreement between the City and Denver Public Schools (DPS) whereby the Chief Financial Officer shall annually from 2017 to 2025, request City Council to appropriate an amount equal to the applicable City Retained Tax (CRT) percentage multiplied by Stapleton tax-increment revenue attributable to the DPS 2016 election. This transfer will help DPS in constructing an additional elementary school on a site at Stapleton to meet future student population demands.
