Convert 19th Ave and 20th Ave from Broadway to Park Avenue from 1-Way to 2-Way streets, convert Grant from 18th to 20th from 1-Way to 2-Way Street. Modify existing traffic signals at 19th & Broadway, 19th & Lincoln, 19th & Park Ave, and 20th & Park Ave, and add a new signal at 19th & Clarkson. Replace existing intersection curb returns to incorporate curb extensions and curb ramps. Installation of storm drain manholes and inlets. Installation of bike lane elements and striping. Awarded Bid also converts Logan from 18th to 20th from 1-Way to 2-Way.
