Type and Scope of services to be performed: This amendment will add an additional \$250,000 in UDFCD funds; \$100,000 in SEMSWA funds; and \$250,000 in CCD Wastewater enterprise funds to the Cherry Creek from Monaco Pkwy to Iliff Ave project. These funds will be used for construction of drainage and flood control improvements along Cherry Creek to stabilize the creek and improve habitat and recreation. The project is being managed through design and construction by the UDFCD.
