The purpose of these funds is to reduce the number of Denver families in poverty by providing employment services to TANF participants, thereby increasing work participation and improving the chances for self-sufficiency. This particular contract will provide employment placement and retention services to those TANF participants that DHS deem "job-ready." As such, it is anticipated that this contract will serve approximately 30% of the full TANF caseload. The grantor is the U.S. Department of Human Services; the funds are provided to Denver's Department of Human Services through the Colorado Department of Human Services. Through an MOU, DHS provides these funds to Denver Workforce Services (OED). The appropriation request of \$1,767,520 is for period of performance from July 1, 2017 through June 30, 2018.
