This amendment will add an additional \$250,000 in UDFCD funds; \$100,000 in SEMSWA funds; and \$250,000 in CCD Wastewater enterprise funds (total \$1,600,000) to the Cherry Creek from Monaco Pkwy to Iliff Ave project, for a total of \$3,700,000. These funds will be used for construction of drainage and flood control improvements along Cherry Creek to stabilize the creek and improve habitat and recreation.
