This project is to permanently protect adjacent residential properties located on the northern project boundary from flooding. The project will provide improved and enlarged stormwater detention facilities with inclusion of water quality features in the City-owned natural area immediately south to the Garrison/Union Park. Along with new landscape and irrigation improvements, a new concrete trail system will be constructed to connect the existing trail system to the neighborhood and the Garrison/Union Park. Also included is the Add Alt. 1 to construct the west trail loop.
