Licenses are required by the Department of Aviation to provide permitted activities on Aviation property to Support Development. The license agreement will allow the District and Developer to perform certain "Permitted Activities" shall mean the following: (i) general construction traffic access, ingress and egress; (ii) stockpiling and grading of soil and fill; (iii) maintenance and use of such stockpiled and graded soils; (iv) construction and maintenance of public utilities and infrastructure; and (v) installation and maintenance of storm water management controls as set forth in the District's Storm Water Management Plan Permit.
