This ordinance will authorize an amendment with Denver Health & Hospital Authority-Transitional Residential Treatment through contract number 2015-23052-03 to add \$230,759 to their current contract. The contractor will provide up to 10 Transitional Residential Treatment (TRT) beds to individuals within a comprehensive continuum of care at DHHA's detoxification center, Denver CARES. The Contractor will serve a minimum of 30 clients over the one year term, and will include services to individuals with high, undermanaged addiction levels who are frequent and/or repetitive users of costly public services including criminal justice, emergency medical or mental health services and/or detoxification services.
