Aramark Sports and Entertainment Services, LLC shall provide food, alcoholic and non-alcoholic beverages, and retail services, including concession, banquet and cater services, and consignment services for Denver Arts & Venues at the Denver Coliseum and Red Rocks Amphitheatre. This is a hybrid revenue/expenditure concession agreement over a three (3) year period with the option of two one-year term extensions via an amendment. This contract will generate revenue for Arts & Venues and provide hospitality services to patrons of Red Rocks and the Coliseum.
