This request is a consolidation effort being initiated to reduce the amount of administrative burden the city, as well as the funder, incur in processing the Continuum of Care (CoC) grants each year. The program is working toward consolidating all projects into one grant, where as previously DDHS would process ten separate grants each year. This phase of the consolidation will combine all the CoC programs having a November 1st start date. This includes the following projects: Women's Lowry & Veterans. The current funds will be rescinded from Women's Lowry and combined into the surviving project which will be named Veterans.
