This ordinance request seeks approval to transfer and appropriate \$4,791,388 million from the Series 2016 (2C) Dedicated Tax Flow of Funds to the new Colorado Convention Center capital special revenue fund (38422). These funds are excess revenue derived from the City and County of Denver's recent settlement surrounding hotel lodgers tax revenue. Specifically, it is requested that \$1,765,248 million be transferred from fund 38420 (NWC/CCC/Other Tourism Projects Fund) and \$3,026,140 million be transferred from fund 25500 (Excise Tax Base Account) to the CCC capital special revenue fund (38422) for a total appropriation of \$4,791,388. Funds will be held in reserve for future CCC financings.
