**Type and Scope of services to be performed:** This request is to accept a grant renewal from the CO Dept. of Public Safety, Office for Victim Programs to the Denver District Attorney's Office to support the Domestic Violence and Sexual Assault Programs. Funds support personnel costs in the amount of \$254,258. A match of \$84753 is allocated in the DA's General Fund (a percent of the SA Prosecutor and Director of Special Programs salaries). With the renewal the total award is \$508,516. The grant started January 1, 2017 and will end December 31, 2018. It is a citywide grant. The funds allow us to keep staff on to implement the programs.
