**Type and Scope of services to be performed:** This contract extension enables Rocky Mountain Human Services (RMHS), the State-designated Community Centered Board (CCB) for Denver, to continue funding services and supports for individuals with intellectual and developmental disabilities (I/DD) using dedicated City and County of Denver mill levy revenue for six months. Over half the funding is expected to go directly to individuals with I/DD in Denver or special projects to provide new services for individuals with I/DD in Denver. The remainder is used by RMHS to provide enhanced services above and beyond what Medicaid and the State will cover. The short-term extension gives DHS the opportunity to conduct a community needs assessment and negotiate a more comprehensive agreement with RMHS.
