This is the fourth Amendment to the contract with CH2M Hill Engineers to add Design Services during construction and addition Final Design Services for the Brighton Boulevard 29th to 44th Street Redevelopment Design Project. Modifies existing preliminary and final design contract to include design during construction of the project through 2017, 2018 and 2019. The Brighton Boulevard Redevelopment Project will design and construct critical public infrastructure (e.g. cycle track, sidewalks, curb/gutter, on-street parking and more) on Brighton Boulevard, helping establish Brighton Boulevard as a gateway to Denver.
