La Raza Services, Inc. will work in conjunction with the Colorado Coalition for the Homeless and the Urban League of Metropolitan Denver to implement and operate the Transition from Jail-to-Community (TJC) program. The goal of this program is to reduce recidivism in Denver County through community collaboration that promotes access to services, resources and supportive relationships to persons prior to release from detention or jail continued through reentry and transition into the community.
