Type and Scope of services to be performed:

Amendment to increase spending capacity for tree planting and watering services throughout the City. The invasive emerald ash borer (EAB) has the potential to kill as many as 330,000 trees in Denver, and the demand for new trees to be planted as a result of the EAB program is greater than what was originally anticipated in 2016. Due to this risk, the demand for new trees to be planted as a result of the EAB program is greater than what was originally anticipated in 2016. DPR has planted at least 3,000 trees each year since the contract began in 2016, and the maximum contract amount needs to be increased to accommodate the 2018 planting requests and watering needs. The services will be re-bid to cover the work that is required for 2019 and beyond.
