This is a revenue agreement similar to other revenue agreements with telecom providers AT&T, Sprint, and Verizon to implement a distributed antenna system up at Red Rocks Amphitheatre to provide better telecommunications coverage at the venue. This contract will generate an initial monthly fee of \$4,326.40 which shall increase 4% each year of the term of the agreement.
