Repairs may include slab levelling (both concrete and flagstone), concrete sidewalk joint grinding and both concrete and flagstone replacement with concrete. Landscape/Irrigation system protection/replacement and traffic/pedestrian control are ancillary to the contract and will be paid for separately
