**Type and Scope of services to be performed:**

William Lyons Home is redeveloping 115 acres at the southeast corner of 48<sup>th</sup> and Chambers called Denver Connection West. The project is in the Gateway Impact Fee area; in particular the Irondale Gulch Drainage area. The City and the builder collaborated on completing a Gateway Impact Fee Drainage Project while the builder was actively redeveloping its site. This contract allocates \$500,000 of Gateway Impact Fees and establishes a Gateway Impact Fee credit of \$900,000 for the builder. The impact fee credit will be used by the builder as construction permits are pulled.
