Type and Scope of services to be performed:

This amendment provides the planned and critical continuity of the management and coordination for the NWC Capital Build Program, providing CCD and NWCO with a single-point of management responsibility, accountability, reporting, documentation, closeout and audit support. The contract scope of services remains the same with this amendment. The contract line of authority is assigned to The Mayor's Office of the National Western Center from the Department of Public Works per Executive Order 141. This amendment extends the current contract term by five (5) years to end on January 31, 2025 and increases current contract capacity amount to \$57,250,000 including \$37,250,000 for program management services, \$6,000,000 for project management services, \$9,000,000 for other planning, management and technical services; and \$5,000,000 for additional services capacity to address full delivery of the NWC capital build program through implementation, closeout and warranty. This amendment is capacity only and not a guarantee of future authorizations or payment. The work will be authorized on a Task Order by Task Order basis.
