Atlas Air, Inc., will be leasing 40,239 square feet of Preferential Cargo Ramp Space and 7,042 square feet of ground service equipment parking space on a signatory basis for aircraft parking, cargo loading and off-loading, and other air cargo operations. They started June 6, 2018 under a permit and the lease will start on 8/01/18. This lease will generate an additional \$54,306.00 in new annual revenue for DEN in addition to the rates and charges calculated based on the annual formula.
