This ordinance request seeks approval of three transfers and supporting appropriations, as describe below, to the Colorado Convention Center Capital Fund (38422) to support the COP payment and capital maintenance.

- Transfer \$144,602 from the Convention Center Hotel Fund (11835) to the Colorado Convention Center capital fund (38422) to align the budget with the COP payment schedule.
- Transfer \$3,700,000 of Seat Tax funding (39000) to the Colorado Convention Center capital fund (38422) for conveyance system improvements. This amount was originally held in reserve to support payment requirements for the COP. It is no longer needed for the COP payment and can be directed to other needs at the Colorado Convention Center.
- Transfer and appropriate of \$141,891 of investment earnings from the Convention Center Replacement Fund (38509) to the Colorado Convention Center capital fund (38422) for capital maintenance.
