Executive Summary with Rationale and Impact:

Detailed description of the item and why we are doing it. This can be a separate attachment. This ordinance clarifies that the Developmental Disabilities Fund (Fund No. 13304) is an appropriated fund by rescinding Ordinance No. 280 in the 2014 Series, which changed the budgeting basis of the fund from appropriated to cash basis. The 2014 ordinance was passed because when funds are appropriated there can be gaps between expending authority and revenue received. However, an appropriation-basis is more suitable than a cash-basis status for this particular fund because this fund is solely supported by property tax revenue, which the Budget and Management Office projects and appropriates annually. Despite the 2014 ordinance, the Long Bill has continued to appropriate the annual budget for this fund. This bill request is essentially a correction to reflect current practice of appropriating the annual budget for Fund 13304. The bill also clarifies that the fund is non-lapsing, to ensure that all property tax mill dollars that are intended to support Developmental Disabilities remain in the fund until spent for this purpose.
