**Type and Scope of services to be performed:**

The city first entered into a sublease agreement at 101 W. Colfax Avenue with Denver Post Media/DP Media Network in 2016 to address FTE growth requirements. CCD subleases space on floors 1,7,8 and 9. As part of the amendments, the landlord provided limited tenant improvements on floors 8 and 9. Due to agencies organizational changes and requirements, CCD requested additional essential improvements which requires reimbursing the sublandlord \$320,000. An additional \$50,000 is included in this amendment for future potential services such as carpet cleaning, key copies and minor repairs and improvements.
