As part of the Mayor's Equity Platform and efforts to make Denver a more fair and inclusive city for all, the city is proposing a new section of the DRMC to require payment of a city minimum wage to workers providing covered services (concession services, catering services, hospitality services, maintenance services, ramp and cargo services, security services and miscellaneous

services, as defined by code) under contracts that provide services to the city or on city property, or pursuant to a negotiated agreement. The wage rate will be:

- \$13/hour beginning July 1, 2019
- \$14/hour beginning July 1, 2020
- \$15/hour beginning July 1, 2021
- \$15 + Increase indexed to Denver region annual CPI beginning July 1, 2022 and each year thereafter
