- Seven median nose extensions and pedestrian refuge areas with push buttons for signal activation at Tamarac, 7500 E Hampden, Poplar St, and Oneida Way intersections
- Pedestrian ramps and median refuge at Verbena for installation of HAWK traffic signal by the City
- Median cover material for existing medians between Dahlia St and Ivanhoe St
- A portion of the potential signature median treatment between Monaco Pkwy and Oneida Way
