Vendor will provide continued professional support of Denver's 911 Telephone System. This contract provides vendor maintenance and support of the Denver 911 telephony systems at 950 Josephine and 303 W Colfax. The scope of work includes both the Nortel/Avaya PBX and the Vesta Meridian CTI at the main center located at 950 Josephine and the backup 911 center located at 303 W Colfax. This maintenance contract is only needed to extend the coverage for the current Denver 911 Telephone system through June 30, 2019. A new 911 telephones system is installed at the combined communications center and will go-live in the second quarter of 2019. The new system will replace the older technology in place today and this contract will no longer be needed.
