DEN initiated a forced relocation of the caged storage space on the ramp level on Concourse C for Alaska Airlines, Inc. The airline now has an enclosed storage room that opens out to a preferential gate for the airline. This was done to accommodate the higher and better use by Southwest Airlines to construct an aircraft line maintenance area.
