The purpose of this second amendment is to designate the location of Delta during the construction phase for the main terminal. Delta is a signatory airline at Denver International Airport (DEN). Delta has moved from their existing ticket counter location in the main terminal, Mod 3 East level 6 to a temporary location while work is completed in the main terminal. Their new ticket counter location is in Mod 1 East level 6. This move occurred on 4/1/2018 and Delta will be occupying the new location until Phase 2 is completed. This amendment also incorporates the minimum wage ordinance into Delta's contract.
