In the November 2018 election, Denver voters approved Referred Measure 2E, which created a Fair Elections Fund. This companion ordinance to the 2020 Long Bill creates the SRF to receive appropriated transfers from the General Fund in 2020 and beyond.

The Fund Number will be 11872 and the cost center will be 0701100. Allowable expenses and revenues includes those outlined in the DRMC, Chapter 15, Article III, Division 2 "Denver Fair Elections Act." This is an appropriated, non-lapsing fund.
