As a part of the creation of the Department of Housing Stability (HOST) in the 2020 budget process, grant dollars for the Community Development Block Grant (CDBG) will continue to be administered by Denver Economic Development and Opportunity (DEDO). To properly differentiate the funds from housing services and economic development services, a new grant fund is being established in the Economic Opportunity Special Revenue Fund Series, which is for economic development-focused services. A portion of CDBG dollars will still be available for housing programs under the allowable uses of the grant.

The new fund Number will be 17016 and the cost center will be 0117110.
