Revenues will include Wastewater revenues, interest income, insurance proceeds and other sources. Expenditures will include the purchase of new and replacement vehicles. This Fund will be a cash based, non-lapsing fund.

This bill request also authorizes a cash transfer of \$2,543,000 in 2019 from the Wastewater Management Operations fund, Fund No. 72100. To allow for the transfer, an appropriation in a transfer org in 72100 will be required.
