This ordinance requests the creation of a new Public Works Capital Contributions capital fund (fund number 38805) in the 38000 Grant and Other Money Projects fund series to support the receipt of funds for public works capital projects from partner organizations or private entities. The eligible expenditures in the Public Works Capital Contributions capital fund include capital improvements, such as planning, design, or construction activities for public infrastructure capital projects, including but not limited to transportation and facilities. It will be a revenue-based and non-lapsing fund and will allow capital expenditure based on cash received to the fund. The expending authority will be Executive Director of Public Works. This is an administrative transaction to align Fund structure with capital budget procedures for the Grant and Other Money Projects Fund Series and new financial reporting system.
