The area to be leased to Southwest is 16070.5 sq. ft. of building space and 57,816.5 sq. ft. of ground space. Southwest will pay Denver International Airport's Rates and Charges for the space. Annual rent to the City in 2020 rates is approximately \$181,000 annually. Contract term is Effective Date - 8/31/2024.
