**As part of the development process in 2018, fee title was** inadvertently conveyed to the city by Townhomes on Conejos, LLC, rather an easement, in connection with a required dedication. By this resolution, the city will convey fee title to the property back to Townhomes on Conejos, LLC, which will in turn grant to the city a permanent easement covering the identical area. There is no change in the effected real property; simply, the nature of the estate will be corrected from a fee interest to easement interest and the parties' interests will then appear as intended.
