Type and Scope of services to be performed:

Located at the north end of the NWC campus adjacent to the relocated Denver Rock Island Railroad (DRIR), the 60,000 ft2 Maintenance & Operations building is a renovation of existing warehouse. Future uses include fleet maintenance and indoor and outdoor storage for equipment, supplies, event materials.

City Council approved a contract with Short Elliott Hendrickson (SEH) for design professional services in August of 2018. NWCO is now asking City Council to consider a contract amendment of approximately \$130K for additional design services related to DRIR rail design coordination, grading and drainage design coordination with the adjacent stockyards, and the recently-adopted NWC Design Standards and Guidelines.
